RICK Blocking Peptide

Item No. 301785

Apoptosis is mediated by death domain (DD) and/or caspase recruitment domain (CARD) containing molecules and a caspase family of proteases. DD-containing serine/threonine kinase RIP regulates Fas-induced apoptosis. A novel CARD-containing serine/threonine kinase that regulates apoptosis was recently identified and designated RICK for RIP-like interacting CLARP kinase.¹ RICK contains an N-terminal kinase catalytic domain and a C-terminal CARD domain. The RICK kinase domain has high sequence homology to that of RIP. Overexpression of RICK promotes the activation of caspase-8 and Fas-induced apoptosis. RICK represents a novel kinase that regulates Fas-induced apoptosis. The mRNA for RICK is expressed in multiple human tissues.¹

Laboratory Procedures

This vial contains 200 µg of peptide supplied in 200 µl TBS pH 7.2, containing 0.1% BSA and 0.02% sodium azide. This peptide is derived from the human RICK sequence (amino acids 11-30; PTIPYHKLADLRYLSRGASG) and was used as an antigen for production of the RICK Polyclonal Antibody (Item No. 160785). This blocking peptide can be used in conjunction with Cayman Chemical's RICK polyclonal antibody to block protein-antibody complex formation during immunochemical analysis of RICK.

Store this peptide solution at -20°C. It will be stable for at least two years. To block antibody/protein complex formation, the following procedure is recommended:

1. Mix the RICK Polyclonal Antibody (Item No. 160785) and blocking peptide together in a 1:1 (v/v) ratio in a microfuge tube. For example, mix 20 µl of antibody and 20 µl of peptide.*
2. Incubate for one hour at room temperature with occasional mixing prior to further dilution and application of the mixture to the immunoblot.
3. Dilute the mixture to the final working antibody concentration and apply to the slide or membrane as usual.

*This is a recommended mixture. The minimum amount of peptide needed for complete blocking has not been precisely determined and may vary depending on the sample being analyzed. The amount of peptide required may need to be increased if sufficient blocking does not occur.
