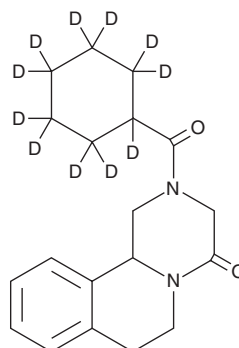

### Laboratory Procedures

Praziquantel-d<sub>11</sub> is intended for use as an internal standard for the quantification of praziquantel (Item No. 20508) by GC- or LC-MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus unlabeled).

Praziquantel-d<sub>11</sub> is supplied as a solid. A stock solution may be made by dissolving the praziquantel-d<sub>11</sub> in the solvent of choice, which should be purged with an inert gas. Praziquantel-d<sub>11</sub> is soluble in chloroform and methanol.

### Description

Praziquantel is an anthelmintic agent.<sup>1,2</sup> It is lethal to *S. mansoni* schistosomula and adults (LC<sub>50</sub>s = 0.68 and 0.03 mg/ml, respectively).<sup>2</sup> Praziquantel (172 and 592 mg/kg) reduces worm burden in a mouse model of *S. mansoni* infection. Formulations containing praziquantel have been used in the treatment of schistosomiasis.
