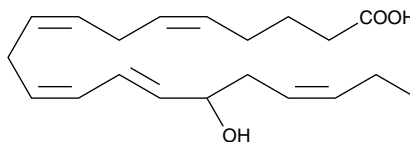

### Laboratory Procedures

For long term storage, we suggest that (±)15-HEPE be stored as supplied at -20°C. It should be stable for at least one year.

(±)15-HEPE is supplied as a solution in ethanol. To change the solvent, evaporate the ethanol under a gentle stream of nitrogen and immediately add the solvent of choice. Solvents such as DMSO or dimethyl formamide purged with an inert gas can be used. The solubility of (±)15-HEPE in these solvents is approximately 50 mg/ml.

Further dilutions of the stock solution into aqueous buffers or isotonic saline should be made prior to performing biological experiments. Ensure that the residual amount of organic solvent is insignificant, since organic solvents may have physiological effects at low concentrations. If an organic solvent-free solution of (±)15-HEPE is needed, it can be prepared by evaporating the ethanol and directly dissolving the neat oil in aqueous buffers. The solubility of (±)15-HEPE in PBS (pH 7.2) is approximately 1 mg/ml. Store aqueous solutions of (±)15-HEPE on ice and use within twelve hours.

(±)15-HEPE is one of the hydroxy fatty acids resulting from random (non-enzymatic) oxidation of eicosapentaenoic acid (EPA). EPA can serve as a substrate for 15-lipoxygenases, which in general will create a chiral hydroxy fatty acid (either 15(R) or 15(S)). (±)15-HEPE can be used as a racemic standard to help distinguish the origins of 15-HEPE of uncertain origin. There are no reports of the biological activity of (±)15-HEPE to date.
