Laboratory Procedures

4-hydroxy Nonenal-d₃ (4-HNE-d₃) contains three deuterium atoms at the terminal methyl position. It is intended for use as an internal standard for the quantification of latanoprost by GC- or LC-mass spectrometry (MS). For long term storage, we suggest that 4-HNE-d₂ be stored as supplied at -80°C. It will be stable for at least six months.

4-HNE-d₃ is supplied as a solution in methyl acetate. To change the solvent, simply evaporate the methyl acetate under a gentle stream of nitrogen and immediately add the solvent of choice. Solvents such as ethanol, DMSO, and dimethyl formamide (DMF) purged with an inert gas can be used. The solubility of 4-hydroxy Nonenal-d₃ in is these solvents is approximately

4-HNE-d₃ is used as an internal standard for the quantification of 4-HNE by stable isotope dilution MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated *versus* unlabeled).

4-HNE is a lipid peroxidation product derived from oxidized ω -6 polyunsaturated fatty acids such as arachidonic acid. 1,2 4-HNE is widely used as a marker of lipid peroxidation. 2 It exhibits various biological activities such as cytotoxicity, growth inhibiting activity, genotoxicity, and chemotactic activity. 1-3 4-HNE inhibits pro-oxidant-induced Ca2+ release from mitochondria at 10-50 µM.²
