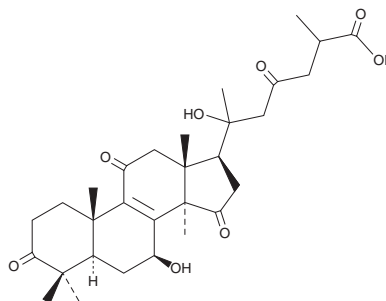

Laboratory Procedures

Ganoderic acid N is supplied as a solid. A stock solution may be made by dissolving the ganoderic acid N in the solvent of choice, which should be purged with an inert gas. Ganoderic acid N is soluble in DMSO.

Description

Ganoderic acid N is a triterpene that has been found in *G. lingzhi* and has angiotensin-converting enzyme (ACE) inhibitory activity.¹ It inhibits ACE in a cell-free assay (IC₅₀ = 0.941 mM).
