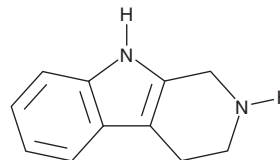

1,2,3,4-Tetrahydro-β-carboline (Item No. 35038) is an analytical reference standard categorized as a β-carboline alkaloid and a tryptamine metabolite.¹ 1,2,3,4-Tetrahydro-β-carboline is a metabolite of N,N-DMT (Item Nos. 13959 | 9003568 | 33586) and tryptamine (Item No. 33682).^{1,2} It is a minor component of ayahuasca, a botanical mixture that has hallucinogenic properties.¹ This product is intended for analytical forensic applications. This product is also available as a general research tool (Item No. 31220).
