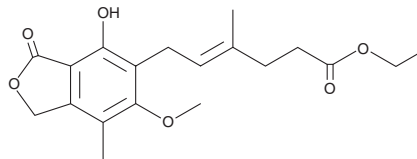

Laboratory Procedures

Ethyl mycophenolate is supplied as a solid. A stock solution may be made by dissolving the ethyl mycophenolate in the solvent of choice, which should be purged with an inert gas. Ethyl mycophenolate is soluble in organic solvents such as ethanol, DMSO, and dimethyl formamide (DMF). The solubility of ethyl mycophenolate in DMSO and DMF is approximately 16 and 20 mg/ml, respectively. Ethyl mycophenolate is slightly soluble in ethanol.

Description

Ethyl mycophenolate is a potential impurity found in commercial preparations of the mycophenolic acid prodrug mycophenolate mofetil.¹
