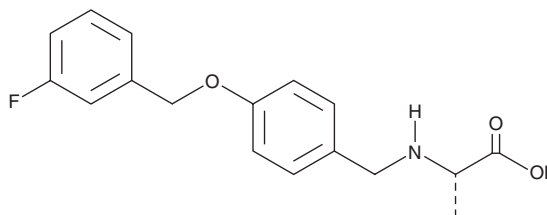

Laboratory Procedures

Safinamide acid is supplied as a solid. A stock solution may be made by dissolving the safinamide acid in the solvent of choice, which should be purged with an inert gas. Safinamide acid is soluble in the organic solvent DMSO.

Description

Safinamide acid is a potential impurity found in commercial preparations of safinamide.¹ It is also a degradation product of safinamide (Item No. 21546) formed under conditions of thermal and oxidative stress.
