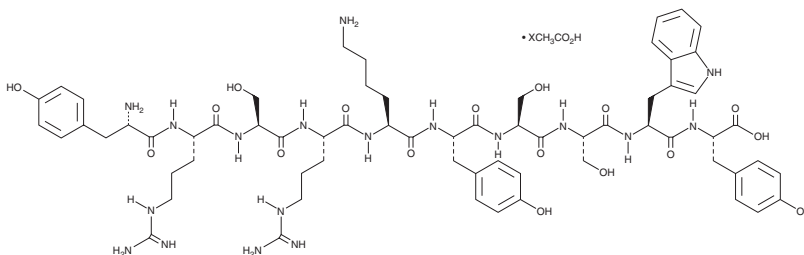

Laboratory Procedures

Decapeptide-12 (acetate) is supplied as a solid. A stock solution may be made by dissolving the decapeptide-12 (acetate) in water. We do not recommend storing the aqueous solution for more than one day.

Description

Decapeptide-12 is a tyrosinase inhibitor and cosmeceutical peptide.¹ It inhibits mushroom tyrosinase (IC₅₀ = 40 μM), as well as human tyrosinase by 35% when used at a concentration of 100 μM.
