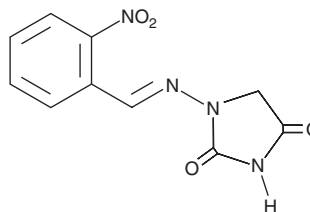

Laboratory Procedures

2-NP-AHD is supplied as a solid. A stock solution may be made by dissolving the 2-NP-AHD in the solvent of choice, which should be purged with an inert gas. 2-NP-AHD is soluble in the organic solvent DMSO at a concentration of approximately 1 mg/ml.

Description

2-NP-AHD is a nitrophenyl-labeled derivative of 1-aminohydantoin (AHD), a metabolite of the nitrofuran antibiotic nitrofurantoin (Item No. 23510).¹ It has been used in immunoassays for the detection of AHD in honey.
