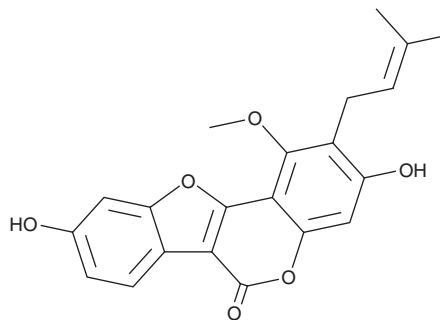

Neoglycyrol is a coumestan that has been found in *G. uralensis*.<sup>1</sup>
