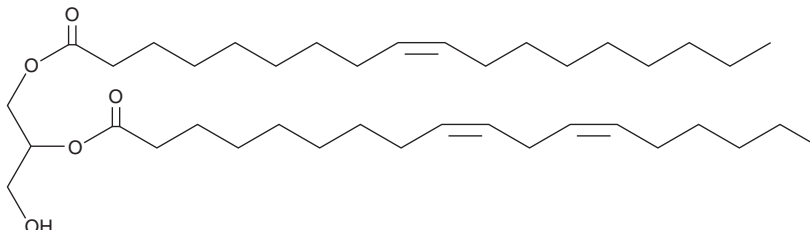

Laboratory Procedures

1-Oleoyl-2-linoleoyl-*rac*-glycerol is supplied as a solution in ethanol. To change the solvent, simply evaporate the ethanol under a gentle stream of nitrogen and immediately add the solvent of choice. Solvents such as chloroform, dichloromethane, DMSO, ethyl acetate, and hexane purged with an inert gas can be used.

Description

1-Oleoyl-2-linoleoyl-*rac*-glycerol is a diacylglycerol that contains oleic acid (Item Nos. 90260 | 24659) and linoleic acid (Item Nos. 90150 | 90150.1 | 21909) at the *sn*-1 and *sn*-2 positions, respectively. It has been found in raw and dry-cured Iberian ham.¹
