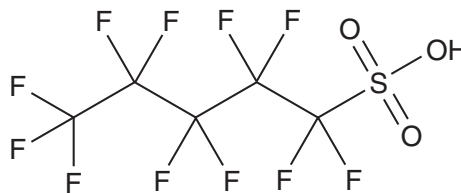

### Laboratory Procedures

Perfluoropentanesulfonic acid is supplied as a solution in ethanol. To change the solvent, simply evaporate the ethanol under a gentle stream of nitrogen and immediately add the solvent of choice. Solvents such as methanol purged with an inert gas can be used.

### Description

Perfluoropentanesulfonic acid is a perfluoroalkyl substance (PFAS).<sup>1,2</sup> It has been found as a contaminant in wastewater and breastmilk.
