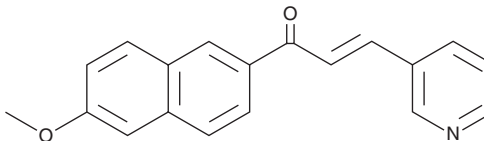

Laboratory Procedures

DMU2139 is supplied as a solid. A stock solution may be made by dissolving the DMU2139 in the solvent of choice, which should be purged with an inert gas. DMU2139 is soluble in the organic solvent dimethyl formamide at a concentration of approximately 10 mg/ml.

Description

DMU2139 is an inhibitor of the cytochrome P450 (CYP) isoform CYP1B1 (IC₅₀ = 0.009 μM).¹ It is selective for CYP1B1 over CYP1A1, CYP1A2, CYP3A4, and CYP2D6 (IC₅₀s = 0.795, 1.2, 10.6, and 5 μM, respectively). DMU2139 enhances cisplatin-induced cell death in HEK293 cells overexpressing CYP1B1.
