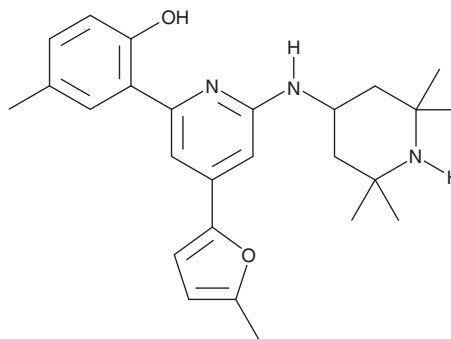

Laboratory Procedures

BRITE338733 is supplied as a solid. A stock solution may be made by dissolving the BRITE338733 in the solvent of choice, which should be purged with an inert gas. BRITE338733 is soluble in organic solvents such as ethanol, DMSO, and dimethyl formamide (DMF). The solubility of BRITE338733 in ethanol and DMF is approximately 1 mg/ml and approximately 3 mg/ml in DMSO.

Description

BRITE338733 is an inhibitor of *E. coli* recombinase A (RecA; IC₅₀ = 4.7 μM for ATP hydrolysis in a cell-free assay), an enzyme involved in DNA repair.¹
