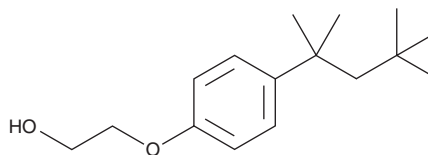

### Laboratory Procedures

4-*tert*-Octylphenol monoethoxylate is supplied as a solid. A stock solution may be made by dissolving the 4-*tert*-octylphenol monoethoxylate in the solvent of choice, which should be purged with an inert gas. 4-*tert*-Octylphenol monoethoxylate is soluble in chloroform and methanol.

### Description

4-*tert*-Octylphenol monoethoxylate is an alkylphenoethoxylate (APE) and a degradation product of non-ionic surfactants, such as 4-*tert*-octylphenol polyethoxylate.<sup>1</sup> It is also a non-steroidal estrogen.<sup>2</sup> 4-*tert*-Octylphenol monoethoxylate has been found in wastewater effluent.<sup>3</sup>
