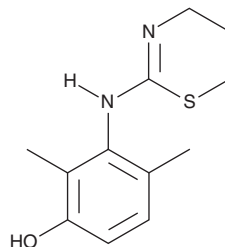

### Description

3-hydroxy Xylazine is a metabolite of the  $\alpha_2$ -adrenergic receptor agonist xylazine (Item No. 14113).<sup>1</sup>
