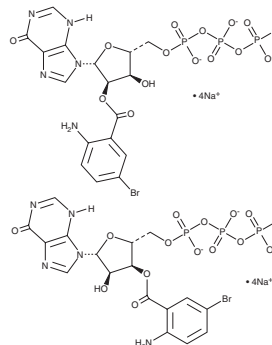

Description

2'-O-(5-Bromoanthraniloyl)inosine-5'-O-triphosphate (2'(3')-bromo ANT-ITP) and 3'-bromo ANT-ITP are fluorescent ITP derivatives, which undergo spontaneous isomerization.¹ 2'(3')-bromo ANT-ITP selectively inhibits mammalian adenylyl cyclase (AC1), AC2, and AC5 over *B. pertussis* AC toxin CyaA (K_is = 7, 22, 4.6, and 920 nM, respectively).
