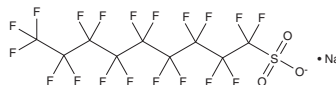

A stock solution may be made by dissolving the perfluorononanesulfonic acid (sodium salt) in the solvent of choice, which should be purged with an inert gas. Perfluorononanesulfonic acid (sodium salt) is soluble in DMSO and methanol.

Description

Perfluorononanesulfonic acid is a perfluoroalkyl substance (PFAS).^{1,2} It has been found in landfill leachate and marine seafood.
