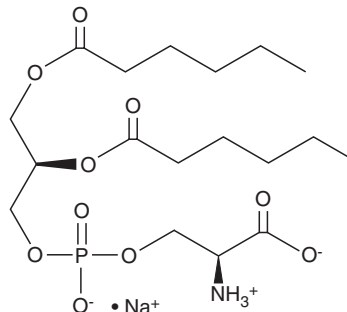

1,2-Dihexanoyl-*sn*-glycero-3-PS (sodium salt) is supplied as a solid. A stock solution may be made by dissolving the 1,2-dihexanoyl-*sn*-glycero-3-PS (sodium salt) in the solvent of choice, which should be purged with an inert gas. 1,2-Dihexanoyl-*sn*-glycero-3-PS (sodium salt) is soluble in methanol.

Description

1,2-Dihexanoyl-*sn*-glycero-3-PS is a phospholipid containing hexanoic acid at the *sn*-1 and *sn*-2 positions.
