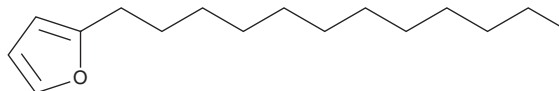

Laboratory Procedures

2-n-Dodecylfuran is supplied as a neat oil. A stock solution may be made by dissolving the 2-n-dodecylfuran in the solvent of choice, which should be purged with an inert gas. 2-n-Dodecylfuran is soluble in organic solvents such as ethanol, DMSO, and dimethyl formamide. The solubility of 2-n-dodecylfuran in these solvents is approximately 25, 5, and 50 mg/ml, respectively.

Description

2-n-Dodecylfuran is an intermediate in the synthesis of thermally cleavable surfactants.¹
