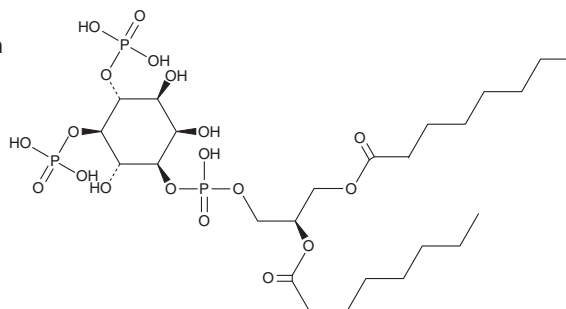

PtdIns-(4,5)-P₂ (1,2-dioctanoyl) is supplied as a solid. A stock solution may be made by dissolving the PtdIns-(4,5)-P₂ (1,2-dioctanoyl) in water. We do not recommend storing the aqueous solution for more than one day.

Description

PtdIns-(4,5)-P₂ (1,2-dioctanoyl) is a synthetic derivative of phosphatidylinositol.¹ It has been used to study the substrate specificity profile of inositol polyphosphate-5-phosphatase A (5ptase).
