Contents: This vial contains concentrated Eicosanoid Affinity Column Buffer (0.5 M phosphate solution, pH 7.0, containing 2.5 M sodium chloride and 0.25% sodium azide).

Stability: ≥2 years at room temperature

IMPORTANT

Water used to prepare all EIA reagents and buffers must be deionized and free of trace organic contaminants ('UltraPure'). Use activated carbon filter cartridges or other organic scavengers. Glass distilled water (even if double distilled), HPLC-grade water, and sterile water (for injections) are not adequate for EIA. UltraPure water may also be purchased from Cayman (Item No. 400000).

Buffer Preparation

This buffer has been formulated specifically for use with Eicosanoid Affinity Columns as a sample application and column wash buffer. It may not perform as described if used with other assay reagents or protocols.

To prepare for use, dilute the concentrated Eicosanoid Affinity Column Buffer 1:5 with UltraPure water.
