

Laboratory Procedures

Ouabain-d₂ is intended for use as an internal standard for the quantification of ouabain by GC- or LC-MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus

Ouabain-d $_3$ is supplied as a solid. A stock solution may be made by dissolving the ouabain-d $_2$ in the solvent of choice, which should be purged with an inert gas. Ouabain-d₃ is slightly soluble in methanol.

Description

Ouabain is a cardiac glycoside that has been found in S. gratus and has diverse biological activities.¹⁻⁷ It inhibits the Na $^+$ /K $^+$ -ATPase isoforms $\alpha 1\beta 1$ and $\alpha 2\beta 1$ and human-ether-a-go-go (hERG), also known as K_v 11.1 (IC₅₀s = 97, 90, and 15.2 nM, respectively).^{2,3} Ouabain reduces the proliferation of PC3 prostate cancer and U937 lymphoma cells (EC₅₀s = 210 and 94 nM, respectively).⁴ It inhibits the cytopathic effect of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) in infected Vero cells (IC₅₀ = <0.097 μ M).⁵ Ouabain (~8 µg/animal) increases systolic blood pressure in normotensive rats.⁶ It has been used to induce ventricular arrythmias in vivo. 7 Formulations containing ouabain have been used in the treatment of atrial fibrillation, atrial flutter, and heart failure.
