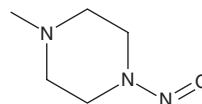

N-Methyl-N'-nitrosopiperazine is supplied as a neat liquid. A stock solution may be made by dissolving the N-methyl-N'-nitrosopiperazine in the solvent of choice, which should be purged with an inert gas. N-Methyl-N'-nitrosopiperazine is soluble in chloroform.

Description

N-Methyl-N'-nitrosopiperazine is a potential impurity in various pharmaceutical preparations, including sartans, non-steroidal anti-inflammatory drugs (NSAIDs), and thiazide diuretics.^{1,2}
