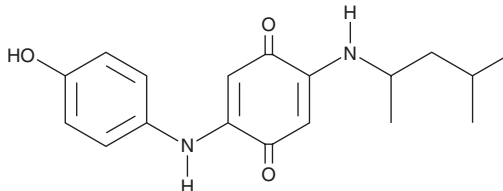

Laboratory Procedures

p-hydroxy 6-PPD-Q is supplied as a solid. A stock solution may be made by dissolving the *p*-hydroxy 6-PPD-Q in the solvent of choice, which should be purged with an inert gas. *p*-hydroxy 6-PPD-Q is slightly soluble (0.1-1 mg/ml) in acetonitrile and sparingly soluble (1-10 mg/ml) in chloroform.

p-hydroxy 6-PPD-Q is a hydroxylated derivative of the 6-PPD derivative 6-PPD-Q (Item No. 38247).
