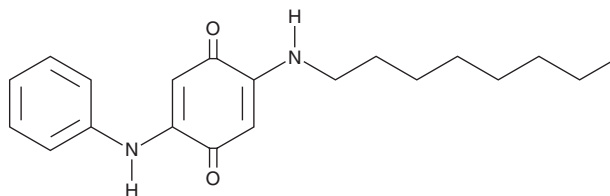

OPPD-Q is supplied as a solid. A stock solution may be made by dissolving the OPPD-Q in the solvent of choice, which should be purged with an inert gas. OPPD-Q is slightly soluble (0.1-1 mg/ml) in methanol and sparingly soluble (1-10 mg/ml) in chloroform.

### Description

OPPD-Q is a *p*-phenylenediamine-quinone (PPD-Q) and an oxidized derivative of the aromatic amine antioxidant OPPD (Item No. 40732).
