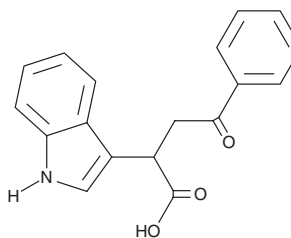

Laboratory Procedures

PEO-IAA is supplied as a solid. A stock solution may be made by dissolving the PEO-IAA in the solvent of choice, which should be purged with an inert gas. PEO-IAA is sparingly soluble (1-10 mg/ml) in ethanol and DMSO.

Description

PEO-IAA is an auxin antagonist.¹ It slows shoot growth and suppresses auxin-induced apical dominance in *C. sativa* seedlings when used at a concentration of 10 μ g/L in growth media.
