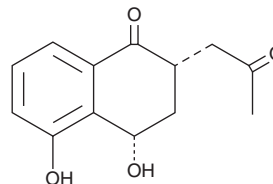

Bhimanone is supplied as a solid. A stock solution may be made by dissolving the bhimanone in the solvent of choice, which should be purged with an inert gas. Bhimanone is soluble in ethanol, methanol, dichloromethane, and DMSO.

Description

Bhimanone is an acetylated tetralone that has been found in *Streptomyces*.¹
