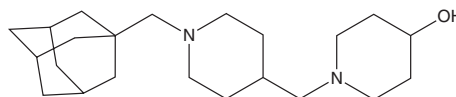

Laboratory Procedures

SQ-609 is supplied as a solid. A stock solution may be made by dissolving the SQ-609 in the solvent of choice, which should be purged with an inert gas. SQ-609 is sparingly soluble (1-10 mg/ml) in ethanol.

Description

SQ-609 is an antibacterial agent.¹ It reduces the proliferation of *M. tuberculosis* in *M. tuberculosis*-infected J774 macrophages (MIC = 4 µg/ml). *In vivo*, SQ-609 (10 mg/kg per day) increases survival time in *M. tuberculosis*-infected female mice.
