Prepare the primary antibody by diluting 1:100 in 1X Transcription Factor Antibody Binding Buffer diluted according to the procedure as outlined below. Add 100 µl of diluted p53 Antibody to each well except the Blank (Blk) wells. Discard any unused diluted primary antibody.
