To use the Lipid Droplets Assay Oleic Acid as a positive control in Cayman's Lipid Droplets Fluorescence Assay Kit (Item No. 500001), dilute the solution 1:5,000-1:100,000 into your culture medium and culture the cells in this medium at 37°C for six to 24 hours.
