TBS-Polysorbate Stock Solution (10X, pH 7.4)

Contents: This bottle contains 250 mM Tris-base, pH 7.4, 1.37 M sodium chloride, containing 27 mM KCl, 0.4 mM phenol red, and 1.0% (v/v) polysorbate.

Stability: ≥1 year at 4°C

Laboratory Procedures

This bottle contains a concentrated solution of filtered TBS-polysorbate. It is ready to use as supplied. For long term storage, we suggest that this product be stored at 4°C; it should be stable for at least one year.

To prepare for use, dilute the concentrated TBS-polysorbate to 10 L by adding 1 part stock with 9 parts UltraPure water (*i.e.*, 1 L stock into 9L UltraPure water). If the concentrated TBS-polysorbate has been frozen, it may remain slightly gelatinous or contain crystals even after thawing. This is normal and will disappear upon dilution. The bottle should be rinsed with the diluted TBS-polysorbate to ensure that all the salts are removed. Diluted TBS-polysorbate may be stored for several weeks at room temperature; the pH of this solution will be ~7.4.
