Contents: This vial contains 10 µl of Orexin A in PBS, containing 0.1% BSA.

### **Laboratory Procedures**

Orexin A is supplied as a solution in PBS for use as a positive control in Orexin Receptor Reporter Assay Kits (Item Nos. 600240 and 600250). When used at a 1:1,000 dilution to treat cultured cells, Orexin A induces a 5-8 fold increase in Secretory Alkaline Phosphatase (SEAP) activity, depending on the cell type and stimulation time. This stock solution should be stored at -80°C.
