Laboratory Procedures

PGE₂ Positive Control is supplied as a 6 mM solution in DMSO for use as a positive control in EP Receptor Reporter Assay Kits and EP Receptor (rat) Plate Assay Kits (cAMP method) (Item Nos. 600340, 600350, 600380, and 600410). When used at 4 µM to treat cultured cells, PGE₂ induces a 20-50 fold increase in Secretary Alkaline Phosphatase (SEAP) activity, depending on the cell type and stimulation time. This stock solution should be stored at -20°C.
