**Contents:** This vial contains contains 50 µl of Myeloperoxidase Inhibitor, 4-aminobenzhydrozide (4-ABH), in DMSO.

Stability: ≥1 year at -20°C

#### Laboratory Procedures

Prior to use, dilute the Cell-Based Myeloperoxidase Inhibitor 1:100 in the Assay Buffer (prepared from Cell-Based Assay Buffer Tablet, Item No. 10009322).

To test the myeloperoxidase specificity of the samples, add 10 µl of this Working Solution along with 40 µl of sample supernatant to corresponding wells of a 96-well plate. Mix with 50 µl of TMB Substrate Solution (Item No. 400072) and incubate at room temperature for 10 to 30 minutes. The Cell-Based Assay Myeloperoxidase Inhibitor is stable for at least one year at -20°C.
