- Contents:** This vial contains 150 µl of P19 cell nuclear extract.
Stability: ≥1 year at -80°C.
Storage: It is recommended that the positive control be aliquoted at 25 µl per vial and stored at -80°C to avoid loss in signal from repeated freeze/thaw cycles. The thawed protein should be stored on ice.
Application: This P19 nuclear extract is provided as a positive control in Cayman's Oct4 Transcription Factor Assay Kit (Item No. 601080).

Laboratory Procedures

Add 10 µl of the positive control to each well of the plate as specified in the Oct4 Transcription Factor Assay Kit booklet (Item No. 601080). The cell lysate will provide a strong signal (>0.5 AU at 450 nm) when used at this concentration.
