Contents: This vial contains 120 µl of human recombinant dipeptidyl peptidase IV (DPP (IV)).

Stability: ≥1 year at -80°C

## Laboratory Procedures

Prior to use in the DPP (IV) Inhibitor Screening Assay Kit (Item No. 700210), thaw the enzyme on ice, add 480 µl of diluted DPP Assay Buffer (Item No. 700211) to the vial, and vortex. The diluted enzyme is stable for two hours on ice. One vial of enzyme is enough DPP to assay 60 wells. Use the additional vial if assaying the entire plate.
