Contents: This vial contains 300 µl of 5 mM H-Gly-Pro conjugated to aminomethylcoumarin (AMC).

Stability: ≥1 year at -20°C

Laboratory Procedures

Prior to use in the DPP (IV) Inhibitor Screening Assay Kit (Item No. 700210), dilute 120 µl of Substrate with 2.88 ml of diluted DPP Assay Buffer (Item No. 700211), and vortex. Prepare additional Substrate as needed. The diluted Substrate is stable for six hours at room temperature. The addition of 50 µl to the assay yields a final concentration of 100 µM Substrate.
