**Contents:** The vial contains 5 ml of 500 mM Tris-HCl, pH 8.0, containing 1.37 M NaCl, 27 mM KCl, and 10 mM MgCl<sub>2</sub>

**Stability:** ≥1 year at -20°C

### Laboratory Procedures

Dilute 3 ml of Assay Buffer (10X) with 27 ml of HPLC-grade water. The final Assay Buffer (50 mM Tris-HCl, pH 8.0, containing 137 mM NaCl, 2.7 mM KCl, and 1 mM MgCl<sub>2</sub>) is used in the SIRT2 Direct Fluorescent Screening Assay Kit (Item No. 700280). The diluted Assay Buffer is stable for six months at -20°C.
