Laboratory Procedures

The Substrate, when stored as supplied, is stable for one year at -20°C. The vial contains 1.2 ml of a 4.25 mM ethanolic solution of 4-nitrophenylacetate. The Substrate is ready to use in the Monoacylglycerol Lipase Inhibitor Screening Assay Kit (Item No. 705192). The final concentration of the Substrate in the assay is 250 μ M. This concentration may be reduced with ethanol at the user's discretion, particularly when complete inhibition curves are required for IC₅₀ or K_i determination. The K_m for the Substrate is 500 μ M.
