Laboratory Procedures

The Assay Buffer (10X), when stored as supplied, is stable for one year at -20°C. Dilute 3 ml of Assay Buffer concentrate with 27 ml of HPLC-grade water. This final Assay Buffer (10 mM Tris-HCl, pH 7.2, containing 1 mM EDTA) should be used for the dilution of the MAGL (human recombinant) Assay Reagent (Item No. 705194) prior to performing the Monoacylglycerol Lipase Inhibitor Screening Assay Kit (Item No. 705192). The diluted Assay Buffer is stable for at least six months at -20°C.
