**Contents:** This vial contains 500 mM Tris-HCl, pH 8.0.

**Stability:** ≥1 year at -20°C

### Laboratory Procedures

Prior to use in the Superoxide Dismutase Assay Kit (Item No. 706002), dilute 2 ml of Sample Buffer concentrate with 18 ml of HPLC-grade water for assaying 96 wells. Prepare additional Sample Buffer as needed. This final Sample Buffer (50 mM Tris-HCl, pH 8.0) should be used to prepare the SOD Standard (Item No. 706005) and dilute the SOD Assay Xanthine Oxidase (Item No. 706006) and SOD samples prior to assaying in the Superoxide Dismutase Assay Kit (Item No. 706002). When stored at 4°C, this diluted Sample Buffer is stable for at least six months.

This product has been tested and formulated to work exclusively with the Superoxide Dismutase Assay Kit from Cayman (Item No. 706002).
