Laboratory Procedures

Prior to use in the Superoxide Dismutase Assay Kit (Item No. 706002), transfer 50 µl of the supplied solution to another vial and dilute with 19.95 ml of diluted SOD Assay Buffer (10X) (Item No. 706001). Cover with tin foil. The diluted radical detector is stable for two hours. This is enough Radical Detector for 96 wells. Prepare additional detector as needed.
