Contents: These vials contain 150 μ l of xanthine oxidase.

Stability: \geq 1 year at -20°C

Laboratory Procedures

Prior to use in the Superoxide Dismutase Assay Kit (Item No. 706002), transfer 50 μ l of the supplied enzyme to another vial and dilute with 1.95 ml of SOD Assay Sample Buffer (10X) (Item No. 706003). Store the thawed and the diluted xanthine oxidase on ice. Once thawed, the xanthine oxidase is stable for four hours. The diluted enzyme is stable for one hour. Do not refreeze the thawed enzyme. This is enough Xanthine Oxidase for 96 wells. Prepare additional Xanthine Oxidase as needed.
