**Contents:** This vial contains 5 mM potassium phosphate, pH 7.4, containing 0.9% sodium chloride.

**Stability:** ≥1 year at 4°C

### Laboratory Procedures

Dilute 3 ml of assay buffer concentrate with 27 ml of HPLC-grade water. This final assay buffer should be used to reconstitute the antioxidant assay chromogen (Item No. 10004873), antioxidant assay metmyoglobin (Item No. 10004875), and to dilute the antioxidant assay trolox (Item No. 10004876) prior to performing the Antioxidant Assay Kit (Item No. 709001). The diluted assay buffer is stable for at least six months at 4°C.
