#### Laboratory Procedures

This vial contains a solution of ovine COX-1 and should be kept on ice when thawed. The COX Standard, when stored as supplied, is stable for one year at -80°C. The enzyme is ready to use as supplied. A 10 µl aliquot of the enzyme per well causes an absorbance, at 590 nm, of approximately 0.28 under the standard assay conditions outlined in the COX Activity Assay Kit booklet (Item No. 760151).
