Bee Venom PLA₂ Control

Item No. 765016

Laboratory Procedures

The vial contains 100 µl of bee venom PLA₂ in 10 mM Tris-HCl, pH 7.5, containing 0.9% NaCl and 0.2% BSA. To avoid repeated freezing and thawing, the PLA2 can be aliquoted into several small vials. Bee venom PLA3, when stored at -20°C, is stable for one year. This enzyme can be used as a positive control for both the sPLA2 and cPLA2 Assay Kits using the following procedures.

1. sPLA₂ Assay Kit (Item No. 765001)

Transfer 10 μl of the supplied enzyme to another vial and dilute with 990 μl of diluted sPLA, Assay Buffer (Item No. 765010) and use within one hour. A 10 μl aliquot of this diluted enzyme per well causes an increase of approximately 0.1 absorbance unit/minute under the standard assay conditions described in the sPLA₂ Assay kit instructions.

2. cPLA₂ Assay Kit (Item No. 765021)

Transfer 10 µl of the supplied enzyme to another vial and dilute with 490 µl of diluted cPLA2 Assay Buffer (Item No. 765030) and use within one hour. A 10 µl aliquot of the diluted enzyme per well causes a final absorbance of approximately 0.7 under the standard assay conditions described in the cPLA2 Assay kit instructions.
