### Immunogen

Peptide with sequence GEKNGDAKTFWME-C, from the N Terminus of the protein sequence according to NP\_114121.2; NP\_001153780.1.

### Purification and Storage

Purified from goat serum by ammonium sulphate precipitation followed by antigen affinity chromatography using the immunizing peptide.

Supplied at 0.5 mg/ml in Tris saline, 0.02% sodium azide, pH7.3 with 0.5% bovine serum albumin.

Aliquot and store at -20°C. Minimize freezing and thawing.

### Applications Tested

**Peptide ELISA:** antibody detection limit dilution 1:1000.

**Western blot:** Approx 85kDa band observed in nuclear lysates of cell line HeLa (calculated MW of 81.9kDa according to NP\_114121.2). Recommended concentration: 1-3µg/ml. Primary incubation was 1 hour.

### Species Reactivity

**Tested:** Human

**Expected from sequence similarity:** Human, Mouse, Rat, Dog, Pig, Cow
