Immunogen

Peptide with sequence LSATPLYGNVHSW-C, from the N Terminus of the protein sequence according to NP_060215.4; NP_001116855.1; NP_001116856.1; NP_001116857.1.

Purification and Storage

Purified from goat serum by ammonium sulphate precipitation followed by antigen affinity chromatography using the immunizing peptide.

Supplied at 0.5 mg/ml in Tris saline, 0.02% sodium azide, pH7.3 with 0.5% bovine serum albumin.

Aliquot and store at -20°C. Minimize freezing and thawing.

Applications Tested

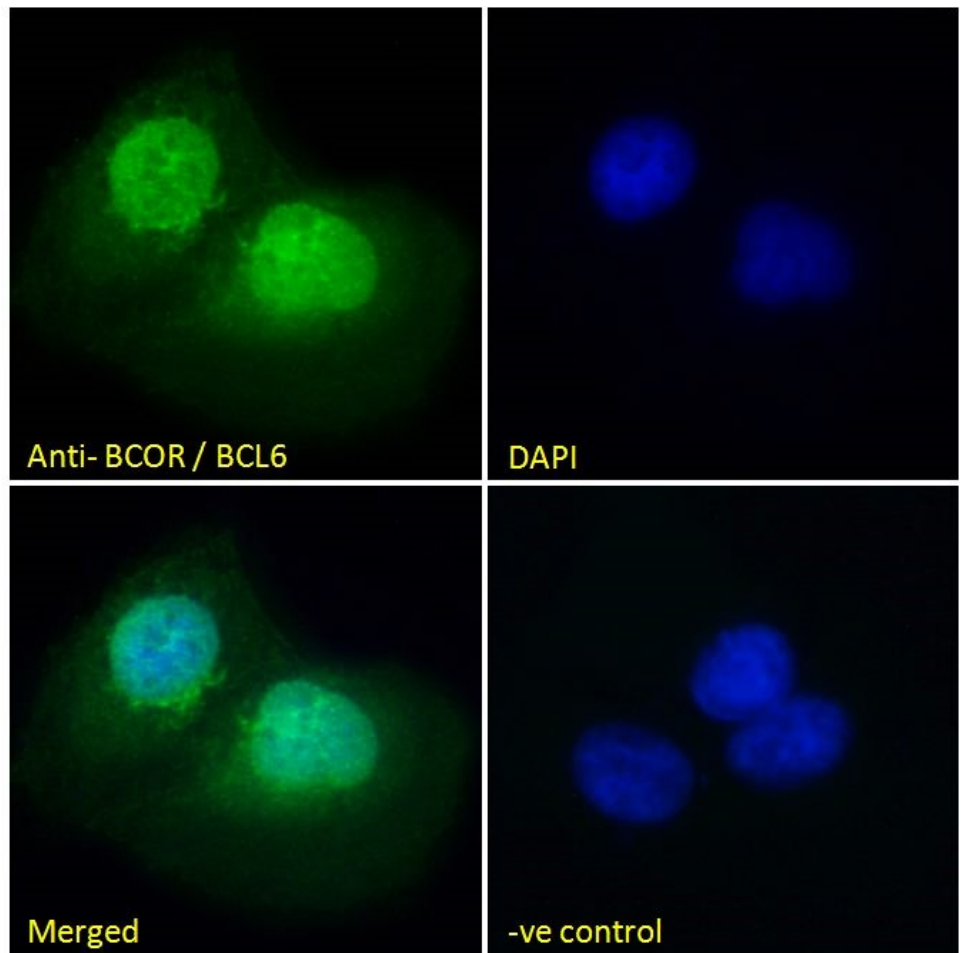
Peptide ELISA: antibody detection limit dilution 1:128000.

Immunofluorescence: Strong expression of the protein seen in the nucleus of U2OS and A431 cells. Recommended concentration: 10µg/ml.

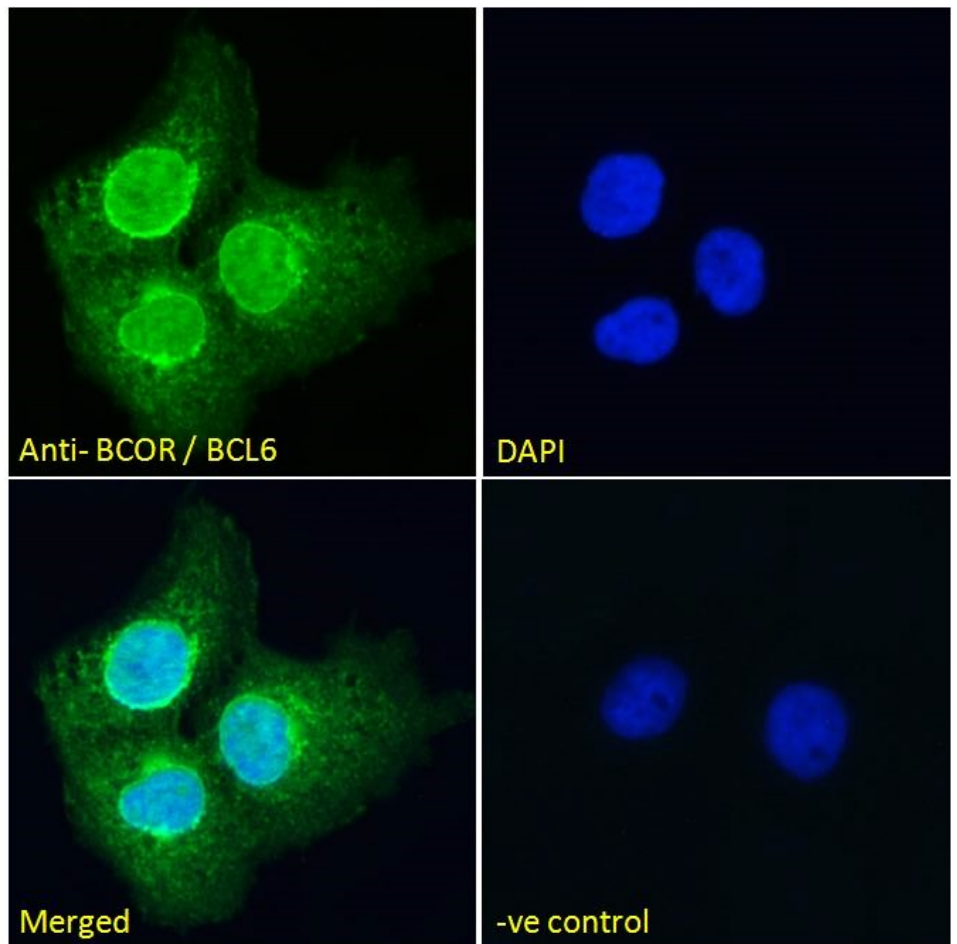
Species Reactivity
